## Position Summary

Ballarat Community Health continues to build our Mental Health and Alcohol and Other Drug integrated teams and programs in Ballarat and the surrounding community. It is an exciting time to become involved in the Community Health Sector. We encourage collaboration across the broad range of programs available to our local community. With the recommendations from the Royal Commission into Mental Health in Victoria, along with a commitment from our Commonwealth Government, via the Western Victoria Primary Health Network, multiple changes and improvements continue for our region.

Step Thru Care is an initiative of the Commonwealth Government, coordinated and funded via the WestVicPHN. The Program will work across the Central Goldfields area, in collaboration with Central Highlands Rural Health, Maryborough and District Health Service and Ballarat Community Health.

The aim of the program is to address the needs of the consumer in a timely and straight forward manner, regardless of whether the primary area of concern is mental ill health or substance use. The program will provide services as and when needed, while incorporating warm referrals and collaborative care with other service providers. While Ballarat Community Health will be the lead agency, we will work closely with our partners to ensure clients are linked with the most suitable provider in their local area. The outcomes will include but not be limited to improved mental health and, or decreased harm from alcohol or other drugs.

The Integrated AOD & MH Clinician will be a member of a dynamic multi-disciplinary, multi-agency team. As the Clinician, you will be responsible for a range of clinical services, including but not limited to, intake, assessments, therapeutic intervention, treatment coordination, care planning, case management, group work, and discharge planning. This will be inclusive of the age span from children to older community members.

### Improve overall health and wellbeing of clients

- Excellent communication skills, ensuring friendly, welcoming, non-judgemental approach
- Flexible approach, with the ability to problem solve, prioritising consumers needs

- Undertake a thorough assessment, including but not limited to identifying the clients immediate needs.
- Deliver evidence-based treatment interventions as part of the treatment plan
- Provide care coordination, including liaison with and warm referral to other services relevant to the treatment goals, including social supports, community involvement and physical health needs
- Facilitate evidence based group programs
- Encourage and facilitate client, carer, family and peer worker involvement
- Foster a collaborative, success-focussed culture with colleagues as part of a multi-disciplinary team which operates across several organisations
- Work closely and collaboratively with the existing AOD and MH teams and services
- Provide clinical expertise to a broad multi-disciplinary team from your area of qualifications and skill set

- Provide secondary support to other members of the team, including the development of documents as required
- Participate in client outcome evaluation and service development
- May require some out of usual business hours requirements

- Demonstrate suitable clinical skills across the age spectrum, with some expertise of integrated care and treatment.
- Experience in providing MH and/or AOD interventions and short term or brief interventions or treatment
- Experience working in an environment with a focus on clients with complex needs
- Understanding of current mental health and alcohol and other drug system, and local service providers
- A strong understanding of and commitment to the social model of health

**2. Interpersonal Skills:**

- Well-developed communication and interpersonal skills, including the capacity to successfully manage difficult situations
- Ability to achieve positive outcomes in a fast paced but flexible environment
- Previous experience with and a passion for inter-departmental collaboration and effective teamwork

**3. Written Communication:**

- Effective written communication skills which are clear and concise
- Desirable but not essential - ability to document relevant assessment tools, including provisional diagnosis and or formulate client information
- Excellent skills in documenting risk profiles, and management of these risks
- All of this above documentation to be completed in a contemporaneous manner
