Position Summary

Ballarat Community Health are building our mental health, and integrated or dual diagnosis teams and programs in Ballarat and the surrounding community. It is an exciting time to become involved in the Community Health Sector. We encourage collaboration across the broad range of programs available to our local community. With the recent recommendations from the Royal Commission into Mental Health in Victoria, along with a commitment from our Commonwealth Government, via the Western Victoria Primary Health Network, multiple changes and improvements will continue for Ballarat Community Health.

HeadtoHealth is an initiative of the commonwealth government in response to the impacts of COVID 19 in Victoria, with this funding continuing. The aim of the Program is to address the mental health needs of community members referred to the service through the PHN intake and assessment services. The outcomes include improved mental health or symptom stability.

The Mental Health Clinician will function as a member of a dynamic multi-disciplinary, multi-agency team. As the Mental Health Clinician, you will be responsible for a range of clinical services, including treatment coordination, intake, mental state examinations, risk assessments, care planning, case management, group work and discharge planning.

Principal Areas of Responsibility

Improve overall health and wellbeing of clients

- Being one of the first points of contact for the program, excellent communication skills, ensuring friendly, welcoming, non-judgemental approach vital
- Flexible approach required, with the ability to problem solve, prioritizing consumers needs necessary
- Undertake a thorough intake assessment, including but not limited to identifying the client's immediate needs
- Deliver evidence-based treatment interventions as part of the treatment plan
- Provide care coordination, including liaison with and referral to other services relevant to the treatment goals, including social supports, community involvement and physical health needs
- Encourage and facilitate client, carer, family and peer worker involvement
- Support a plan including warm referrals to suitable service providers or agencies
- Foster a collaborative, success-focussed culture with colleagues as part of a multidisciplinary team which operates across several organisations
- Provide secondary support to other members of the team, including the development of documents as required
- Participate in client outcome evaluation and service development

Reporting

- Complete and maintain appropriate clinical records and statistical reports according to the
 organisation's policy and funding body standards. All of which is to be done in a
 contemporaneous manner
- Ensure all data and other reporting requirements of funding bodies are submitted as required

- Ability to provide treatment across the whole of the age spectrum
- Experience in providing clinical mental health interventions, including short term treatment
- Experience working in an environment with a focus on clients with complex needs, including integrated or dual diagnosis clients.
- Understanding of current mental health system, and local service providers
- A strong understanding of and commitment to the social model of health

2. Interpersonal Skills:

- Well-developed communication and interpersonal skills, including the capacity to successfully manage difficult situations
- Ability to achieve positive outcomes in a face paced but flexible environment
- Previous experience with and a passion for inter-departmental collaboration and effective teamwork

3. Written Communication:

- Effective written communication skills which are clear and concise
- Ability to document all necessary mental health assessments, including provision diagnosis and or formulate client information.
- Ability to document a treatment plan including client goals, and positive treatment outcomes.
- Excellent skills in documenting risk profiles, and management of these risks

- Strong knowledge of and ability to use the Microsoft Office Suite and Windows based programs and database management systems
- Ability to quickly adapt to the various different systems being utilized for the program

- Proven ability to prioritise workloads and conflicting tasks and manage deadlines
- Strong ability to respond to demands in a timely manner, including client or family unplanned presentations
- Experience in active participation in Multi-Disciplinary team Meetings, including offering clinical guidance, mentoring and direction as or if needed
